

Proposed Template/Format of third ENSREG Report to European Council and European Parliament. For discussion and agreement by ENSREG at its meeting on 23 January 2013.

Timetable for production of the report

If the regular activity Report of the Group, due in July 2013, should be available for distribution at the European Nuclear Safety Conference of 11/12 June 2013 the timetable for production of the report would be the following:

- 23 January 2013 - draft Template tabled at ENSREG Meeting. ENSREG to agree Template and assign responsibility for preparation of text
- 25 February 2013 - first drafts of text to Chairman, including Chapter 6
- 14 March 2013 - compiled report to ENSREG members for comment
- 9 April 2013 - comments back to Chairman
- 16 April 2013 - comments incorporated and new draft to ENSREG members for discussion at meeting End April/Early May ?
- End April/Early May 2013 ? - ENSREG to discuss and agree report including future actions
- End May - final comments incorporated – final report forwarded to ENSREG members and printer
- 7 June - printer copies available
- 10 June - Report forwarded to European Council and European Parliament
- 11 June - Report available for ENSREG Nuclear Safety Conference 11-12 June 2013

Content of the Report

The purpose of the report is primarily to update the European Council and the European Parliament on the work of ENSREG since July 2011 when ENSREG's second report was published.

The proposed content is based primarily on the work programme. Some work areas may not be sufficiently advanced for inclusion in the report and these can be deleted. As the work of last two years was dominated by the EU Stress Tests (and Follow-up) we introduced a chapter dedicated to it.

It is assumed that the authors would be the Chairman and Chairs of the Working Groups (the Chair of the Steering Committee of the ENSREG Conference and the Project Manager Stress Tests respectively) as for the second report.

General Guidance for preparation of the text

- Report should be as succinct as possible
- Main text should be no more than 30 pages (excluding Annexes)
- Target Audience (i.e. Council and Parliament – generally non-technical) needs to be kept in mind. A certain amount of context and description of existing systems is necessary.
- Layout and language should be as simple as possible, without sacrificing accuracy
